## **EXECUTIVE SUMMARY**

The quarter ended one of the most interesting legislative sessions in recent memory. After a six-week delay past the scheduled May 2 adjournment, Governor Ron DeSantis officially signed the \$117.4 billion Florida State Budget for fiscal year 2025-2026. The Legislature finalized the budget and an accompanying tax package on June 16, and DeSantis signed it into law on June 30. The final budget includes several key victories for businesses, infrastructure, housing, and tourism—particularly benefiting St. Johns County

The Chamber also hosted the St Johns County 2025 Health and Wellness Roundtable. This event, attended by over 40 healthcare and education leaders, focused on addressing talent pipeline and attainable housing challenges now and in the future. Key points included the need for 3,500 additional healthcare staff over the next 5-7 years, with projected state-wide shortages in nurses, technicians, therapists, and other critical roles. Educational institutions highlighted their efforts in developing career pathways, establishing clinical partnerships, and offering customized training programs.

The Chamber published an updated <u>Attainable Housing Report</u>. Attainable workforce housing is a critical issue in St. Johns County, impacting not only the local economy but also the fabric of the community. Essential workers — teachers, law enforcement, nurses, manufacturing workers and service industry employees — are the backbone of our economy and contribute to the high quality of life we enjoy in St. Johns County. However, many of these workers are unable to afford to live in the very county they serve due to a severe lack of housing within an attainable price range. The Attainable Housing Coalition is actively working to identify and address these challenges by advocating for policies and solutions that foster the development of attainable housing options.

We congratulate Viv Helwig, owner of Vested Metals, for being named the North Florida Small-Business Person of the year. The SBA North Florida district recognized Viv for his impact and economic contributions to the region. Mr. Helwig earned recognition due to his remarkable entrepreneurial journey—transforming a small, single-office startup into a thriving enterprise with a significant market presence. His leadership overcame early challenges to achieve substantial growth, expanding the company's footprint and driving impressive sales through innovative marketing strategies.

### ST. JOHNS COUNTY LEGISLATIVE UPDATE



DeSantis Signs \$117.4
Billion State Budget:
Major Wins for St. Johns
County Businesses,
Infrastructure, and
Tourism

After a six-week delay past the scheduled May 2 adjournment, Governor Ron DeSantis officially signed the \$117.4 billion Florida State Budget for fiscal year 2025-2026. The Legislature finalized the budget and an accompanying tax package on June 16, and DeSantis signed it into

law on June 30. The final budget includes several key victories for businesses, infrastructure, housing, and tourism—particularly benefiting St. Johns County.

#### **Major Tax Relief for Businesses**

One of the most significant changes is the elimination of the 2% sales tax on commercial rents, a long-standing priority of the St. Johns County Chamber of Commerce. Starting October 1, 2025, Florida businesses will no longer be subject to this tax, which is projected to save \$900 million statewide each year. Local businesses in St. Johns County are expected to benefit greatly from this tax relief, easing financial burdens and promoting economic growth.

#### **Tax Package Delivers Broad Relief**

The sweeping tax package includes several new exemptions and permanent savings for Floridians:

- The aviation fuel tax will be repealed starting January 1, 2026.
- The popular Back to School Sales Tax Holiday has been made permanent and will run every August.
- Permanent sales tax exemptions have been approved for essential items like batteries, smoke detectors, generators, bicycle helmets, sunscreen, and admission to Florida State Parks.
- A new Hunting, Fishing & Camping Sales Tax Holiday will run from September 8 through December 31, 2025..

### **2025 HEALTHCARE ROUNDTABLE**

The Chamber recently hosted the St Johns County 2025 Health and Wellness Roundtable. This event, attended by over 40 healthcare and education leaders, focused on addressing talent pipeline and attainable housing challenges now and in the future. Key points included the need for 3,500 additional healthcare staff over the next 5-7 years, with projected state-wide shortages in nurses, technicians, therapists, and other



critical roles. Educational institutions highlighted their efforts in developing career pathways, establishing clinical partnerships, and offering customized training programs. Still, they noted that there is also a shortage of instructors and a limited capacity to expand programs to meet the demand. It was noted that a strategic effort would be needed in local education and recruitment from outside the region to meet the demand.

The discussion emphasized the importance of artificial intelligence, technology integration, and addressing housing and transportation issues to attract and retain talent. The Chamber plans to advocate for increased density and affordable housing to support workforce needs. Several hospitals and other medical facilities addressed the need for some form of public transportation to allow lower-paid employees an opportunity to commute to work from lower-cost-of-living locations. There may be an opportunity to partner with other municipalities to expand public transportation in our county.

Another critical factor is educating students on the wide variety of occupations within healthcare. The Chamber proposed expanding the high school showcase event and establishing a dedicated healthcare table to highlight the various career pathways in the medical field. The goal is to go beyond traditional roles, such as nursing, and show students and parents the diverse opportunities available in healthcare. Healthcare facilities can provide collateral materials, and educational institutions can showcase different career options, salary potential, and academic pathways. By having representatives from hospitals, colleges, and technical schools present, we can provide direct information about job shadowing, internships, and career progression. The key is to demonstrate that healthcare offers multiple entry points and career tracks, not just becoming a doctor or nurse, which can help attract more students to the field.

With the goal of business retention and expansion in mind, the county has a vested interest in ensuring that an adequate workforce exists. This includes the development of the talent pipeline, infrastructure, quality of life concerns, and technology that are important to the targeted demographic. The goal is to create a sustainable, attractive business environment that supports growth and innovation.

Addressing this crisis through the development of workforce housing is imperative to reduce commuter dependency, ease infrastructure strain, and enhance the quality of life for residents and workers alike. The Attainable Housing Coalition is committed to driving meaningful change through several key initiatives, including:

- Advocating for zoning and policy changes to support attainable housing development.
- Encouraging public-private partnerships to increase funding and investment in workforce housing projects.
- Engaging with the community to shift perceptions and highlight the necessity of targeted growth
- Supporting infrastructure improvements that align with housing expansion to create sustainable, livable communities.

By taking proactive steps to expand attainable housing opportunities, St. Johns County can ensure a thriving, balanced community where essential workers are not just contributors — but also residents who can live, work and invest in the future of the county.

At its core, AcceleratePV exists to provide hands-on mentorship, expert-led education, and a strong support network for entrepreneurs. The organization's goal is to create an environment where local businesses can launch, grow, and thrive—with guidance every step of the way.

# FIRST COAST TECHNICAL COLLEGE HASTINGS CAMPUS UPDATE



The Hastings Mainstreet Association's May meeting focused on First Coast Technical College's new Hastings Campus. Dr. Brennan Asplen discussed the renovation of Hastings High School, funded by a \$7.6 million ARPA grant and \$10 million from the school district, totaling \$17 million. The project, expected to be completed by December 2026, includes structural repairs, new windows, and a 1924 roof replacement. The first phase focuses on the building's exterior and a complete renovation of the first-floor interior.



Mr. George Mastordis, Director of Firs t Coast Technical College (FCTC), provided an update on the various programs scheduled to be offered on the campus. FCTC will offer programs like early childhood education and development, adult education and testing, medical assisting, cosmetology, and ESL programs. In addition, there will be community space and an early childhood daycare facility for the area. Mr. Mastordis said, "We know some of our students struggle to find childcare so they can attend classes. Having childcare on site will allow those students to succeed and advance their education."

Plans on the campus include an additional 20,000 sq. ft. workforce education building funded by a \$9.4 million EDA grant and \$1.8 million from the district. This project will provide a state-of-the-art training facility with classrooms and hands-on lab space to meet the growing demand for workforce training across the region. Initially, FCTC will offer Diesel Systems with an agricultural focus and a technical program focused on Solar and



Alternative Energy. There is also plenty of land for future expansion. The workforce training facility is scheduled to be completed in March 2028.




# Q3 – ALL PROJECTS IN THE PIPELINE FOR ST. JOHNS COUNTY

### STAGES OF A PROJECT IN THE PIPELINE


STAGE	DESCRIPTION
Suspect	EFI referrals, JAXUSA referrals, Chamber Member/Local Referrals, and Direct Inquiries with at least a 10% potential of moving forward.
Project	The project has real potential to select St. Johns County for new business, relocation, or expansion. The representative either has an existing business, has visited, or plans to visit St. Johns County.
Imminent	St. Johns County has been shortlisted among other potential locations.
Announced Pending	The project has selected St. Johns County and awaiting final approvals from County and other agencies to move forward.
Announced	The project has selected St. Johns County, and all final approvals are complete.




- At the end of Q3, there were a total of 28 active businesses in the pipeline. The announced pending project should be revealed in quarter three.
- These projects represented a wide variety of industrial types.




- There are a total of fourteen businesses in the pipeline for the targeted industries of Advanced Manufacturing/Aviation (7 projects), and Health and Biomedical (7 projects).
- The Education prospect is also directly related to manufacturing/aviation.



- JaxUSA continues to refer new projects. Quarter three had a significant increase over quarter two.
- Twenty-eight (28) total projects remained in the pipeline.



- Current projects in the pipeline will feature service or commercial space (4 projects), industrial or manufacturing space (8 projects), health or medical facilities (7 projects), warehouse/distribution (4 projects), retail/entertainment space (4 projects) and education/training space (1 project).
- The Foundry Project on World Golf Parkway added 500,000 square feet of warehouse/ light industrial space in quarter two of 2025. The 500,000 square foot KeHE project is in the final stages of construction with a ribbon cutting scheduled in quarter 4.



- The majority of the current projects in the pipeline seek to lease (13 projects) or build-tosuit space (7 projects).
- Four projects indicated an interest in purchasing an existing building in St. Johns County while the other four were open to exploring all options.
